VISION & MISSION

"My dream is to unleash the potential of a billion people through upliftment and empowerment and see that India becomes an economic superpower"

I am glad that the new government led by charismatic Hon'ble Prime Minister Narendra Modi recognises the importance of foreign investments, joint ventures, technology transfers, co-production, public private partnerships and best management practices in all streams. This complicates the entire legal system and Indian courts are now full of long-pending disputes.

In a free market economy, a protectionist approach towards employees results in a unproductive and lethargic workforce lacking the spirit to excel. The balance of power between workers and managements gets disturbed, leading to industries losing competitive edge in Domestic and International markets.

We require highly motivated workers for businesses to prosper. But there is no law to prosecute a person who has no desire to work hard. An employee's desire to perform well should come from within. The most important triggers to motivate people are financial incentives, job security and job progression but they cannot be given by forcing employers into submission. In today's world, the way to create more stable employment opportunities is by encouraging investments. The competition among employers to get good employees and 'a war for talent' will ensure that workers are treated in a fair manner and their commitment is honoured.

I believe foreign investments should be promoted in a major way to create conducive work environments across the country. However, many investors – those already present in Indian market and others wanting to enter – have apprehensions about existing labour laws and time-consuming litigations. Bhartiya Legal Support Foundation is a forum comprising of legal experts specialising in employment issues which provides a platform for seminars and conferences where managements, bureaucrats, corporate executives and potential investors can interact, allay their apprehensions on certain issues, work towards simpler laws and encourage smooth flow of investments in a positive atmosphere.

Having travelled across the world and while interacting with non-resident Indians, I realised that many of them are doing extremely well in their fields. They want to contribute to India's growth but are wary of the complex legal systems. With decades of expertise and access to key decision makers, we work towards clear policies backed by smooth regulatory mechanisms to attract investments so that lives of a billion people can be improved.

As Late Dr A.P.J. Abdul Kalam said: "Dream is not that which you see while sleeping, it is something that does not let you sleep." We are committed to do whatever it takes to ensure that India emerges as a major investment destination.
